Legislative News/Events:

- Senate Bill 411 passed both houses and was signed into law by the Governor. The bill consolidates corrections and parole. Corrections Officers now have Peace Officers status while on duty. The PSCOA was able to negotiate with lawmakers and the Department of Corrections to add the following language to the bill. This language can be found on page 37 of the bill: "Powers of peace officers. A chief administrator, deputy superintendent or corrections officer of a State correctional facility may exercise the powers of a peace officer in the performance of that individual's duties generally in: (1) Guarding, protecting and delivering inmates. (2) Protecting the property of the department. (3) Capturing and returning inmates that may have escaped within the immediate area of a State correctional facility or mode of transport. For the purposes of this section, the immediate area of a State correctional facility or mode of transport shall encompass the curtilage up to and including one half of a mile." This was no small feat. It required a lot of lobbying to get this language added to the bill.
- Senate Bill 569 (Investigative Procedures Act) is currently sitting in the Labor and industry committee. The IPA is what was commonly referred to as the CO Bill of Rights. We changed a lot of language in this bill and included FSE's who were left out of the previous attempts to get this type of language signed into law. If you would like to read the bill, simply google Senate bill 569 2021 and will come up in word form and PDF. Nothing is a sure thing, but I believe this may be our best attempt at finally passing a bill that gives the H-1 membership certain due process rights and allows us to stay in a pay status and retain health benefits, until administrative type investigations are completed. We have worked hard to garner support for this bill. Most of the meetings that you see below were held to explain and lobby for legislator's support.

Contract:

- We had many meetings in the last year concerning the contract. We met with our law firm once a week, every week beginning back in April to get ready to present at arbitration. Leading up to the arbitration, we solicited information from union leaders from nearby states concerning pay and working condition language. We used the information that was obtained from the contract survey that was conducted a few months back. We gathered and used information that was given to us when we spoke to members at local meetings and when touring jails. We reviewed every page of our current contract, looking for areas that we felt needed language upgrades. That is how we came up with the proposals that were presented to the panel.

The PSCOA presented to the panel May 24th through the 27th. The Commonwealth presented June the 16th through the 18th. The transcripts from the arbitration were received on 7/6/21. Both sides have 30 days to write briefs, starting from 7/6. Executive sessions will be scheduled after the briefs are turned in. At this point there is nothing to report moving forward. I hope that we have a ruling from the arbitrator soon. There is no way for me to give you a possible date.

Main Office Audit:

- Last year, John and Ray began the process of reviewing spending of all Main Office Official and Business Agents, Current and Past. The internal review has been completed. All spending from the Main Office for the last seven years has been turned over to an independent auditor.

Current Officers, Business Agents and prior Officers and Business Agents expenditures have been turned over to the auditor. There is a lot of documentation to review. This will take some time. We hope to have the results of the audit in a few months.
